PROPOSED AMENDMENTS FO THE SAHETI CONSTITUTION TO BE CONSIDERED AT THE ANNUAL GENERAL MEETING OF THE SOUTH AFRICAN HELLENIC EDUCATIONAL AND TECHNICAL INSTITUTE, CIVIN DRIVE, SENDERWOOD

Proposed Change One:

Inclusion of the additional immovable property that was correctly registered on 5th of November 2024 in the section 1. DEFINITIONS – IMMOVABLE PROPERTY

Current wording:

IMMOVABLE PROPERTY: The land presently registered in the name of the INSTITUTE being RE of portion 2 of the farm Bedford Registration Division 68 I.R TRANSVAAL, measuring 290539 square metres and any other immovable property which may be acquired by the INSTITUTE

Proposed wording:

IMMOVABLE PROPERTY: The land presently registered in the name of the INSTITUTE being RE of portion 2 of the farm Bedford Registration Division 68 I.R TRANSVAAL, measuring 290539 square metres **and Section 55 on Sectional Plan Number SS35/1981 in the scheme known as Glendower Place measuring 107 square meters** and any other immovable property which may be acquired by the INSTITUTE

Proposed Change Two:

Correct the reference error in 23.2 under section 23. THE SAHETI ASSOCIATIONS

Current wording:

23.2. follow and implement the directions and/or requirements of the BOARD and shall if so directed by the BOARD and, as provided for and envisaged in 19.1.4 above, amend, vary correct or replace any Constitution, Rules, Regulations or powers applicable to any such SAHETI ASSOCIATION, and/or its members and/or office-bearers, from time to time;

Proposed wording:

23.2. follow and implement the directions and/or requirements of the BOARD and shall if so directed by the BOARD and, as provided for and envisaged in 19.2.4 above, amend, vary correct or replace any Constitution, Rules, Regulations or powers applicable to any such SAHETI ASSOCIATION, and/or its members and/or office-bearers, from time to time;

Proposed Change Three:

Removal of the of the association “the SAHETI Foundation” that has been deregistered by the Companies and Intellectual Properties Commission, it is unable to be re-registered and has ceased to be an active association of SAHETI for a number of years as described in the section 1. DEFINITIONS - ASSOCIATIONS

Current wording:

The committees and/or associations, including but not limited to those mentioned hereunder, which function as support groups for the INSTITUTE and/or SAHETI SCHOOLS and who have filed their constitutions and/or registration certificates with the HEAD OFFICE, after having been approved by the Board, namely:

the SAHETI Parent Teachers Association of the Pre-Primary School and Play School;

the SAHETI Parent Teachers Association,

the SAHETI Ladies Committee;

the SAHETI Alumni Association which association consists of former scholars who attended or graduated from SAHETI SCHOOL;

and

the SAHETI Foundation, which is the body established in terms of section 21 of the former Companies Act, 61 of 1973.

Proposed wording:

The committees and/or associations, including but not limited to those mentioned hereunder, which function as support groups for the INSTITUTE and/or SAHETI SCHOOLS and who have filed their constitutions and/or registration certificates with the HEAD OFFICE, after having been approved by the Board, namely:

the SAHETI Parent Teachers Association of the Pre-Primary School and Play School;

the SAHETI Parent Teachers Association,

the SAHETI Ladies Committee;

and

the SAHETI Alumni Association which association consists of former scholars who attended or graduated from SAHETI SCHOOL;
